- 1. Call to Order (13:30)
  - a. Bucky called the meeting to order at 13:35.
- 2. Welcome/Introductions
  - a. Visitors / New Members
  - b. Sign Roll / Update Rosters
  - c. August 2016 Minutes
    - i. Randy Willden made motion to approve. Seconded by Dave Gibby. All in favor.
- 3. Reports/Action-Local Incident Briefs
  - a. Fires West Government (Vernon)
    - i. Fire lasted 10-15 days. Handled by volunteer responders and State Fire and BLM. Fire was located at Erickson Pass. Road closures were in place. Precautionary evacuation was called in the town of Vernon. Temporary Shelter was opened. 100 % contained. \$932,000 was cost of fire and will be covered by State.
  - b. MM 66- Fire was difficult for crews to reach. It went to air attack. Handled very quickly.
  - c. Fiber Optic Line Break Sept 15, 2016
    - i. Tooele Valley sustained a fiber optic line break in Lake Point. Redundant line had been planted but wasn't active at the time of outage. Major disruption for internet, landline and cell phone service. EM will be hosting a meeting with Century Link and other fiber line companies. Commissioners will be involved.
      - 1. 911 lines were switched from Tooele County to Utah County where they were routed back to our dispatch. Dispatch was still in operation.
      - 2. Sprint has microwave coverage for backup. Other carriers do not.
      - 3. Wendover was able to maintain communication with dispatch by locking down on their channel.
      - 4. There is an Amateur Radio Club in Tooele. They will send someone to the EOC for communications in an emergency.

- d. Rain storm took down radio capabilities for a short time due to a lighting strike at Nelson Peak and hail storm at another site.
  - i. If you ever key up and don't have radio service, make sure you lockdown to your channel.

- a. Utah LEPC Statewide Conference Sept 1st 2016
  - i. Bucky and Beckie attended the LEPC conference in Provo. The need for LEPC's was reiterated. The EPA website has the conclusion from the ammonium nitrate explosion. Tier II is basically the same.
- b. TCEM Open House Sept 12, 2016
  - i. EM had several hundred people come to the Open House. It was a success.
- c. Commodities Flow Study September 14th and 15th
  - i. Traffic patterns were monitored and hazardous materials carriers were counted. Information will be presented at a future date.

- a. Summary of Mass Casualty Drill at Wendover Air Field September 21, 2016
  - i. Casey Snyder- Drill was needed for FFA requirements. Small group started meeting and conducted a drill where a plane came off runway and casualties were incurred. 150 passengers. EOC acted as dispatch, Sheriff's Office, Airport Office and Wendover Ambulance participated. Scenario included Nevada. A school bus was used to simulate an airplane. Drill took about 2 ½ hours. From EOC perspective things went very well. After action report will be published.
