## **Minutes 7-26-17**

4. **TCHD Presentation and Approval of the new Tooele County Health Department (TCHD) All Hazards Plan**

### **Background:**

Scott McKenzie previously provided monthly updates on the development of the revisions to the TCHD's All Hazard Plan during the January, February, March, April, May and June LEPC Meetings. On July 17, 2017, the Draft TCHD All-Hazards Plan was provided electronically to all members of the Local Emergency Planning Committee (LEPC) and our other community partners for review and comment.

### **Presentation:**

Scott McKenzie welcomed members of the LEPC and community partners and thanked them for attending. Scott described the preparation process over the last year for the TCHD's submission for recognition by the National Association of County and City Health Officials (NACCHO) Organization's Project Public Health Ready program.

Project Public Health Ready (PPHR) is a criteria-based training and recognition program that assesses local health department (LHD) capacity and capability to plan for, respond to, and recover from public health emergencies. PPHR aims to protect the public's health and strengthen the public health infrastructure by equipping local health departments with sustainable tools to plan, train, and exercise using a continuous quality improvement

Scott then provided an overview of the completed revision of the TCHD All-Hazards Plan.

The TCHD's updated emergency management program is a direct result of working with all of our community partners over the last year and implementing all of the recommendations from the members of the LEPC and

our other community partners. Scott once again thanked everyone for their participation in completing this project.

**An opportunity to ask any questions or present any concerns was provided.**

Several comments were made about how individuals present appreciated the opportunity for input and how working together on this project has brought the community partners closer together.

**Scott then presented the TCHD's All-Hazard Plan for approval by the members of the LEPC and the other community partners.**

**There was a motion to accept and approve the TCHD's All-Hazard Plan as written by Herman Herrera and the motion was seconded by Karen Worthington. The motion was carried and the TCHD AHP was approved by the entire body of the LEPC.**
