Minutes 6-27-18

1. Call to Order (13:30)

- a. Bucky called the meeting to order 13:00.

2. Welcome/ Introductions

3. Sign Roll / Update Rosters

- a. **April 2018 Minutes-** Herman Herrera made motion to approve. Seconded by Jess Monsen. All in favor.

4. Reports/Action- Local Incident Briefs

- a. Grease Monkey had an unknown substance dropped off that had to be collected and tested. We don't have word back yet on what the material was.
- b. UPDATE- regarding the Grease Monkey incident, the unknown substance that was dropped off there was tested by Grease Monkey's regular used oil hauler/recycler, and it turned out to be clean used oil (which we suspected), so the hauler/recycler took it with their regular load. Incident is closed out.

5. Presentation – Holly Energy (UNEV Pipeline)

- a. Ken McConney with Holly Energy gave a presentation on the UNEV Pipeline. Handouts are attached to minutes.
- b. Discussion about the pipeline running through Tooele County.
 - i. There is a development in Stansbury Park working with the pipeline.
 1. 50 feet is the typical easement for building near the pipeline.
 - ii. There is maintenance work going on for the pipeline in the Vernon/ Rush Valley area.
 - iii. The pipeline is inspected periodically.
 - iv. There was discussion about the pipeline and its current location and changes and development to the I-80 SR 201 road project.

6. Presentation – Tooele Ready Preparedness Mobile Application

- a. Bucky gave presentation on the TooeleReady Mobile App. It is a very interactive app, including lists and information you can store there. You can also take pictures and send the information

to TCEM to inform us of emergency situations. Please help promote the app in your businesses, communities and families.

7. Presentation/Discussion Emergency Drought/Fire Declaration(s) in Tooele County

- a. Bucky discussed current drought/fire declaration for Tooele County. The declaration is in place for property and livestock owners to protect them from drought conditions. There is a great concern about wildfire. Tooele City already made a declaration of imminent fire hazard emergency order.
