Minutes 8-29-18

1. Call to Order (13:30)

- a. Bucky called the meeting to order at 1:38.

4. Reports/Action- Local Incident Briefs

a. Country Fan fest-

- i. From the EMS side- they brought in another medical unit in light of recent events. They rotated units during the entire event. Next year they will press the response side a little more between fire and ems.

1. There was a weather-related issue on the first night. They had a thunder cell come into the area and put the event on hold during that time.

b. Middle Canyon Fire -

- i. The cause of the fire is human caused- still under investigation. It occurred at the same time as the thunder cell at Country Fan Fest. There was an evacuation for one street and some pre-evacuation notices. It was about 10 days in length. The EOC was at staff level activation. There will be an after-action report.

c. WALMART – Unknown fluid leaking from dumpsters

- i. A complaint was filed that there were unknown substances leaking on the ground at Walmart Distribution Center. The complainant was concerned it would affect storm drains.

d. Chemical Suicides-

- i. There have been 2 chemical suicides in Utah this year. The first event caused evacuation of the clinic where the patient was taken. The second event was found to be disbursed thru the mail. Please contact State Fire Marshalls Office if you have any concerns about the mail.

e. Semi Fuel Spill on I-80

- i. The driver was able to stop the spill before the event became too large.

5. Update - Status of Fires in Tooele County –

- a. Bucky gave quick presentation of the Tooele County Wildfire Update.

6. Project - Bomb Making Materials Awareness Program

- a. Tooele County hosted the first bomb making materials awareness program 2 weeks ago. The class teaches the retail community how to monitor the purchase of certain supplies and work with law enforcement to track that.

- a. An individual is wanting to be permitted to store black powder in the mouth of Ophir Canyon. He sells black powder to be used in civil war re-enactment.
