  - b. **Green Ravine Fire in Lake Point –**
    - i. There were 3 property owners involved in the fire area. Kennecott, BLM and a private property owner. Union Pacific has a rail line in the area as well.
    - ii. The area is an alluvial fan- prone to flooding.
    - iii. There were efforts to mitigate the effects early on in recovery. Basins will continue to be placed in the area. Recovery is projected to be 3 years.
    - iv. EM has been working with the affected residents to get sandbags in place.
    - v. The fire was named Green Ravine by the forest service after the name of one of the canyons.
