 - a. Tracy Frailey made motion to approve Sept Meeting Minutes. Travis Tanner seconded. All in favor.

5. Update - Tooele County COVID-19 Response

- a. The county is in a high risk status at the present moment. That means masks are required and in person gatherings have been reduced to 10. You can go to coronavirus.utah.gov website for more information about risk levels and the effect on business and public entities.
- b. Schools Tooele County School District Status
 - i. Tooele High School was recently closed due to COVID case counts. The closure was for 2 weeks but only 6 school days were moved to online. Matt Jackson is the point contact for COVID for the school district. Their website is updated with COVID information everyday at 5:00 PM. They currently have 120 people in quarantine and 25 positive cases
- c. Health High Risk Level Restrictions
 - i. Status of Contact Tracing-COVID
 - **1.** The Health Dept is tracking 25 cases today. Contact Tracing is very time consuming and involved.
 - ii. Update- COVID Vaccine Clinics
 - **1.** The current expectation for the vaccine is early spring. The vaccine will immediately service hospital workers and high risk individuals first.
 - iii. Update Flu Vaccine Clinics
 - 1. Flu Vaccine Clinic will be held Nov 6th at Deseret Peak 9-noon. Adults only.

iv. Forecast for public meetings through 4th quarter 2020 and 1st quarter 2021

6. Update - Tooele City CARES (COVID-19) Small Business Mini-Grant Funding

- a. Total Awarded \$305.270.65 to 19 recipients.
- b. Tooele County has received approx. 27 applications for mini grant funding.
 - i. You can go to www.tooelecares.org to start the process.
- c. Tooele City is in their second round of grant applications. The first round issued 24 grants. The second round closes the end of this week. They are anticipating the second round will be just as busy as the first round. The application and award process are at 2 weeks turnaround time.

7. Update - Tooele County Hazardous Materials Activities.

- a. Integration of PEAC-System into dispatch
- b. PEAC is working to integrate into dispatch centers in some areas. They are displaying on the dispatch screens in the form of a layer
- c. Update Commodity Transporters being added into the PEAC system for Tooele County.
 - i. . PEAC has the ability to put transporters on their screen to show what they are hauling and on what main routes. We also have the ability to add hazmat permitting as a layer.

8. Update - Tooele County Wildfire Status.

- a. State Forester extends until November 30.
- b. Local Incidents:
 - i. Soldier Canyon Fire Summary
 - 1. This fire is being investigated as suspicious as well as homicide.

9. State Reports:

- a. State Fire Marshal Liaison Richard Moseley/ Wade Francis
 - i. They toured the lime plant northwest of Grantsville. Some of the charges will be large. They will work with Dispatch to notify of activity. Not a lot of fire concerns in the area.
 - ii. Another company in the area of 5 Mile Pass is working on getting permitting and working with dispatch so first responders don't go out unnecessarily.
 - iii. They are finishing a radiation transport course in No. Davis. 2 day course, in person, still have availability.
 - iv. They need a count for the new ERG's for the county so they can get them distributed.
