Minutes 1-27-2021

1. **Call to Order (13:30)**

5. **Approve Minutes –October 28, 2021**
 - a. Travis Tanner made motion to approve Oct 2020 meeting minutes. Seconded by Tracy Frailey. All in favor.
6. **Elections – for Industry Co-Chair**
 - a. Randy Willden made motion to retain Scott Johnson as LEPC Co-Chair. All in favor.
7. **Update- State Fire Marshall – Richard Mosely – Blasting Permits in county.**
 - a. New facility at Five Mile Pass. Richard will reach out to them and see what their plans are so Tooele County can be informed. DynaNovel Explosives Manufacturing Site. They continue to have active blasting permits; they approved a location in Grantsville. Richard will always keep the LEPC informed. They are still doing training and can even do live training.
8. **Local Incidents Events -**
 - a. SR-36 Crashes - (November- December)
 - i. Crash at MP 11 on SR 36. Hydrocarbon spill involved an extensive response. In addition, they had a propane truck roll south of Vernon. South responders did a great job handling the incidents.

- b. Fiber Outage - December 27th, 2020
 - i. Fiber connection was lost between SL and Tooele area. A rodent chew caused loss of connection. In the future we hope to hear from Century Link in the LEPC to discuss a redundant line between the valleys.
- c. Sonic Boom from Aircraft not Earthquake – January 25th, 2021
 - i. Hill Air Force Base were conducting night operations.
- d. Dispatch had some cellular and data issues Jan 26th.

9. Update – Tooele County COVID-19 Response

a. Schools Response – Tooele County School District Status

i. Testing and Vaccine Delivery

1. They are testing all students in extra circular activities as well as coaches every other week. They have tested 800-1000 throughout the district. They have a testing center at the district office on Wed afternoons. The District is allowing 4 tickets per student for extracurricular activities maxing out at 25% of capacity. The school nurses and TCHD are doing an amazing job vaccinating. They have done 970 school staff. They have not done every school yet. The second dose of the vaccine will begin in Feb. To date they have 34 positive cases. 56 in quarantine. Total of 535 in quarantine since Aug 2020. School closures over 1500 are based on 1% of school population. Schools under 1500 are limited to 15 cases before closure. If anyone in this group needs a test they can help out.

b. Community Response – Health Department

i. Testing Update - Update-COVID Vaccine Clinics (70+ Clients)

1. 3 day estimated trajectory has been on the decline for the last 14 days, our 7-day rolling average positivity rate is 17.92%, this is the lowest rate since Oct 27. They have given 3134 first doses. They are averaging 700 doses per week. They will begin the second doses clinic next week. They have a testing center at the park and ride on 2400 north. It will be changing to a test Utah site on Monday. New website to register. They are open to 70 and older vaccine now. They have completed first responders and healthcare. They have an online appointment system. They are booked out for Feb for 70+. They are prepared to do larger vaccine clinics as doses allow. You can find info on social media, they have sign boards, website for vaccines.
