- 7. Update on Tier 2 submittals to Tooele County
 - a. Bucky reported that the LEPC is still receiving these submittals. They will continue to place them into PEAC software system once they are all received. PEAC should update their system and be ready for use by May 1st.
- 8. Update-Tooele County COVID-19 Response
 - a. Schools Response-Tooele County School District Status
 - b. Community Response- Health Department
 - i. TCHD is working with the school district to get the vaccine to 16-18 yr olds before school lets out for the summer.
 - ii. There is an 80% effective rate 2 weeks after 1st dose for immunity. 90% effective 2 weeks after second vaccine for full immunity. The J&J vaccine is full immunity 2 weeks after 1st dose.
 - c. Tooele County Recovery Process
 - i. Expiration of Mask Mandate- April 10th
 - 1. Statewide mask mandate will be removed after April 10th. The county is not going to maintain a mask order. Stores and businesses can still require masks for patrons and employees. Please respect everyone's choices. Mass gatherings over 50 people will still require masks.
 - ii. American Recovery Plan Funding
 - 1. Additional stimulus money is coming to local areas. Our county and cities will be receiving funds from this plan.

- 9. New! Business Organization Safety Response Protocol- Standard Protocol for Business
 - a. There are 5 best practice protocols to use when handling emergency situations. The Tooele County School District is using this protocol. This plan will be made available to businesses and organizations. Hold, Secure, Lockdown, Evacuate, Shelter. If you would like to use this you need to notify the I Love You Guys Foundation of intent. Tooele City Police Dept would be happy to come and train business and organizations on this protocol.
- 10. Upcoming Exercises- April 15th 2021 Great Utah Shakeout (Interested Partners)
 - a. April is National Earthquake Preparedness Month. The EOC would encourage all business and organizations to participate in the Shake Out Exercise. We will be testing our damage assessment program Orion. If you are interested in helping us test our system, we are providing training prior to the Shake Out Exercise. Our Exercise will take place on April 15th at 10:15 AM.

 - i. Wade Francis- They are starting to pick up on their training in the State.
 - ii. Richard Moseley- he is working with Davey Bickford. He is also working with WESCO. He will be participating in the Shake Out and providing damage assessments.
 - iii. Cameron Kirkham- DEM moved to their new location in Taylorsville. The State EOC will remain at the Capitol. They are currently revisiting their resurgence plan for COVID. They are going to start scaling down their unified command team. There was a 2500 acre fire in Uintah County. It was a substantial fire for March. There is a drought declaration now.
