 - b. Bryan Slade- Mass Gatherings are not restricted but must meet requirements. With an approved plan and all requirements met the Health Dept may be able to approve those events.
 - c. **Schools Response – Tooele County School District Status**
 - i. They are testing around 1000 people per week/ bi-weekly. They are also providing vaccine at this time.
 - d. **Community Response – Health Department**

- i. Bryan Slade- Clinics 2-3 times a week to administer vaccine. The 2nd dose clinics have started. They may receive more doses per week starting in March, the clinic will move to Deseret Peak at that point. They have been doing 400-500 vaccines per week. The 2nd dose clinic will remain at the Health Dept.

- 1. Mountain West will start helping with 1st dose vaccine by providing staff beginning Tue or Wed next week at Deseret Peak.
