 - a. **Tooele County Flooding Events**
 - i. **August 1st -20th**
 1. During Country Fan Fest we experienced a heavy storm cell. They evacuated the stage area for weather events.
 2. There was some localized flooding in the Tooele City area and surrounding canyons. 2.7 inches of rain was recorded in an hour. 160 homes reported damage from the flooding. The county submitted all documents necessary to see if any kind of assistance will be available.
 3. 2 more episodes followed those storm events. We found some problems on the train tracks and standing water on the roadway.
8. **Update – Tooele County COVID-19 Response - Tooele County Health Department /Mtn. West Medical**

- a. TCHD- Tooele County has a high positivity rate centered in Grantsville. The county is at 50 % vaccination rate. Pfizer has FDA approval. They are taking people with underlying health conditions for boosters currently. The booster is 8 months after the second dose.
- b. MWMC- They have 4 COVID patients in house. The ER is seeing between 8-15 COVID patients per day. Their staff is 88 % vaccinated. Every patient they have admitted has been unvaccinated. They are barely keeping up with staffing and treating patients. Glenn encourages wearing a mask in public places even if you are vaccinated.
